whose specimen signature(s) is/are hereunder recorded, to (1) operate the said Current Account, for and on my/our behalf and hereby request you to honour all cheques drawn on the said Account by him/her/them, notwithstanding that such cheques may create or increase on overdraft to any extent, but without prejudice to your right to refuse to allow any overdraft or increase of overdraft beyond any specified overdraft limit from time to time; (2) give, vary and revoke instructions to you regarding remittances, including telegraphic transfers, and as to the manner in which any money payable by or to us, whether periodically or otherwise is to be paid or dealt with; (3) withdraw any or all money in the said Current Account and to give, vary or revoke instructions to deliver, dispose of, or deal with, any securities, deeds or documents or other property including safe deposit boxes and their contents, whatsoever from time to time in your possession for any of our accounts whether by way of security or safe custody or otherwise ; (4) request any information regarding the said Current Account as he/she/they may require and to receive our statements of account on demand, and (5) generally in all dealings and transactions between us and you to act as fully and effectually for all intents and purposes as we could if personally present and acting in the matters and transactions stated herein, and also in such other matters and transactions as may arise in the course of business for all of which this shall be a sufficient authority to you, AND I/WE HEREBY ALSO notify you that I/WE have authorised the said person(s) on my /our behalf and

on behalf of the establishment to make, draw, accept or otherwise sign any bills of exchange, promissory notes (for account under business name only)

or other negotiable instruments, and to discount them with your bank or otherwise, and also to endorse cheques or other negotiable or mercantile instruments of any description, and I/WE hereby acknowledge and hold myself/ourselves liable thereon in the same way as if they were signed by me/us.

In consideration of your complying in whole or in part with this mandate, we hereby jointly and severally indemnify you against all actions, claims, demands, costs, expenses, liabilities of whatever nature and losses now or hereafter incurred by you in connection with arising out of such compliance. You may at any time at your sole and unfettered discretion and without notice to us combine or consolidate the balances on all or any of our accounts with you and set-off any sum(s) standing from time to time to the credit of any one or more of such accounts (notwithstanding that any fixed deposit has not matured or any of the special conditions applicable to the deposit have not been satisfied) in or towards payment or satisfaction of all or any of our liabilities (including contingent liabilities) to you. We agree that nothing in the arrangements between you and us shall be treated as constituting an implied agreement restricting or negating any lien, charge, pledge, right of set-off or other right which you may currently have expressly or which may be implied by law.

This authority shall continue in force until I/WE have expressly revoked it by notice in writing delivered to you and shall be binding on one personal representatives until you receive written notice of our deaths of either of us (where applicable).
